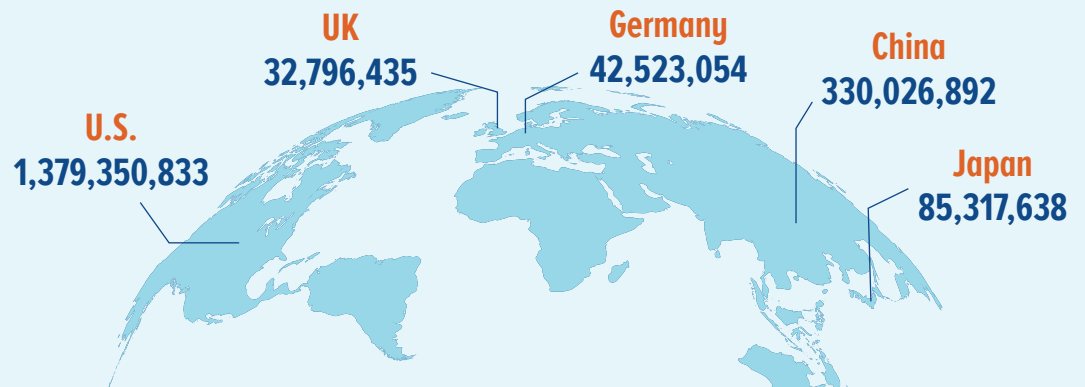
### Data breach is inevitable for most organisations

Multiple departments within organisations are creating, storing and transferring vast amounts of data every day. At the same time, millions of records of personally identifiable information (PII) are lost or stolen every year, resulting in penalties for breach of regulation, increased litigation and damage to brand reputation.

With the introduction of the General Data Protection Regulation (GDPR) effective on 25 May 2018 and the threat of fines up to the greater of Eur20,000,000 or up to 4% of global revenue, the pressure on organisations has never been greater.

## The law governing data protection in Europe is changing



### GENERAL DATA PROTECTION REGULATION (GDPR)

Introduces a single set of rules across the EU on 25 May 2018.



### TIMING

Local regulators must be informed of personal data loss within 72 hours and individuals whose data loss may result in high risk must also be informed without undue delay.



### PERSONAL DATA?

Any data that identifies an individual is personal data. An individual has the right to access their data and to request deletion.



### GLOBAL IMPACT

Applies to organisations based in the EU and any organisation that retains or uses data of EU citizens.



### PENALTY

Fines up to the greater of Eur20,000,000, or up to 4% of annual global revenue.

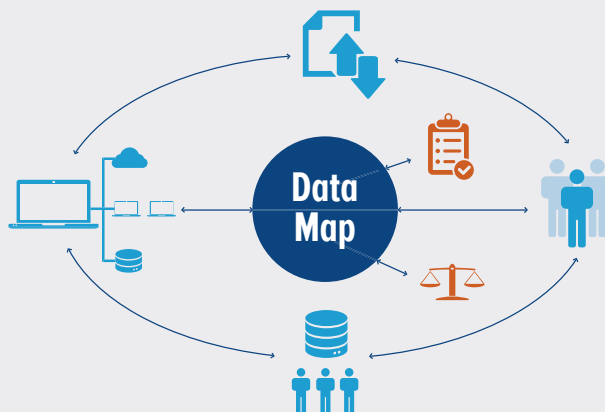

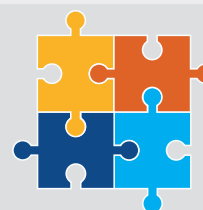
